



Guest and Staff access to Wi-Fi Service

When using Guest and Staff access to Wi-Fi in Uppingham Community College (UCC) there are particulars that must be agreed to before access is granted.

By using UCC's Wi-Fi service you are bound to the relevant UK Law including; Data Protection 1998, Parts of the Criminal Justice and Public Order Act 1994, Computer Misuse Act 1990 and Copyright Legislations. It is your responsibility to familiarise yourself with all Statutory requirements.

In particular, you must not and by using the service agree not to do the following:

- Deliberately visit, view or download any material from any website containing pornographic, abusive, racist, violent or illegal material or material which is offensive in any way whatsoever.
- Download any images, text, sound or other material that is in breach of copyright. UCC accepts no responsibility for any breaches that may occur.
- Upload or make available to others any material that is offensive, obscene, indecent, or which infringes the copyright of another person (e.g. images, MP3 and other audio and video files). The United Kingdom has strict laws on obscenity and Copyright law is applicable to content on the Internet.
- Use the Internet for any illegal activity or gambling.
- Use the Internet to harass, cause annoyance, inconvenience or anxiety to others. Examples would include abusive or offensive emails, spamming, and distributing information regarding the creation of and sending Internet viruses, worms, Trojan Horses, ping, flooding, or denial of service attacks.
- Access, or attempt to gain access to, computer systems, data or resources to which they are not authorised, such as connecting to other user's resources. By using the service you agree to respect the Privacy of others.
- Access network services in such a way as to deny reasonable access to the network for other users, for example, by excessive use of network bandwidth. This could include the use of FTP servers, file-sharing software and video streaming.
- Attempt to gain unauthorised access to restricted part of the network, or attempt to undermine the integrity or security of any computer systems or network. You, the user, are responsible for any damage caused to the computer equipment arising out of any wilful act or negligent misuse.

Breach of the above will lead to users being banned from using the service and may result in prosecution.

The procedure to place your device on the UCC Wi-Fi requires input; MAC address and name of owner to marry up identification on the system. In order to make the Wi-Fi available, these details must be authorised. Should the service no longer be required or the device is changed, lost or damaged; the device will be denied access and removed.

UCC reserve the right to update or modify the above terms at any time without prior notice. Your use of the service following any such change constitutes your agreement to follow and be bound by these terms as modified. For this reason, we encourage you to review these terms whenever you use the service.
