

**DEED OF VARIATION
OF THE
FUNDING AGREEMENT FOR UPPINGHAM COMMUNITY COLLEGE**

The Parties to this Deed are:

- (1) **THE SECRETARY OF STATE FOR EDUCATION** of Sanctuary Buildings, Great Smith Street, London, SW1P 3BT (the "**Secretary of State**"); and
- (2) **UPPINGHAM COMMUNITY COLLEGE**, a charitable company incorporated in England and Wales with registered company number 07556159, whose registered office is at Uppingham Community College, London Road, Uppingham, Rutland, LE15 9TJ (the "**Company**");

together referred to as the "**Parties**".

INTRODUCTION

- A. The Parties entered into a funding agreement dated 24th March 2011, a copy of which is contained in Schedule 1 (the "**Existing Funding Agreement**"), relating to the establishment, maintenance and funding of an academy known as Uppingham Community College.
- B. The Parties now wish to vary and amend the terms and conditions of the Existing Funding Agreement on the terms set out in this Deed.

LEGAL AGREEMENT

1. Words, expressions and interpretations used in this Deed shall, unless the context expressly requires otherwise, have the meaning given to them in, and shall be interpreted in accordance with, the Amended Funding Agreement (as defined in clause 2 below).
2. The Parties agree that with effect from the date of this Deed, the Existing Funding Agreement shall be amended and re-stated in the form of the amended funding agreement set out in Schedule 2 (the "**Amended Funding Agreement**"). For the avoidance of doubt, the Amended Funding Agreement does not terminate or suspend the Existing Funding Agreement but amends and re-states it.

GOVERNING LAW AND JURISDICTION


3. This Deed, and any dispute or claim arising out of or in connection with it, its subject matter or formation (including non-contractual disputes or claims) shall be governed by and interpreted in accordance with the law of England and Wales.
4. The Parties irrevocably agree that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim that arises out of, or in connection with, this Deed or its subject matter or formation (including non-contractual disputes or claims).

COUNTERPARTS

5. This Deed may be executed in any number of counterparts and by the Parties to it on separate counterparts, each of which when so executed and delivered shall be an original, but all the counterparts shall together constitute one and the same instrument.
